

APPLICATION FOR PORT OF ENTRY VISA

A port of entry visa only enables the holder to precede to a port of entry before the expiry date of the visa, where the holder **must comply with the applicable laws, regulations.**

- Valid travel document (passport)

Please note: The document must have **two unused pages following each other in a chronological order** for the issuance of a South African visa.

The travel document / passport should be valid for at least 30 days AFTER departure from South Africa.

- **Non-refundable** Visa fee: CFA 24 000 (twenty four thousand CFA)

Payment must be made by bank deposit. Cash payment is NOT accepted.

Please ensure that the full name of the visa applicant is reflected on the deposit slip. The deposit slip must accompany the application. To avoid underpayment, **deposits from outside Cote d'Ivoire** must consider currency fluctuations (excluding commission charges) when making payment.

- Two (2) recent passport-sized photographs (45mmx35mm showing 70-80% of face).

- Copy of previous passport including visas for South Africa that were affixed on the passport.
- Flight reservations (provisional) for the entire onward and return journey (actual ticket is not necessary). No open returns will be accepted.
In case of transit, proof of onward travel and visa/proof of visa arrangements for country of destination (if applicable).
- Documentary evidence of accommodation in South Africa.

Take note

- No fixed travel arrangements must be made prior to the issuing of a visa.
- Visa applications should reach the office of application at least five (05) to ten (10) **WORKING DAYS** before the planned travel date.
- **No preference** will be given to applicants, applying on short notice.
- The entry requirements are **NOT NEGOTIABLE**.
- Documents to be submitted that are in any language except English must be a **translated by a sworn translator**. Original documents must accompany the translations. Original documents will be returned to the applicant.

DURATION AND PURPOSE OF STAY

The period of residence in the RSA will be determined from the applicant's date of admission to the Republic in accordance with any conditions that may appear on the visa. Applicants must ensure that they request the full duration of their intended visits.

Applicants must ensure that they apply for the correct visa reflecting the true purpose of the visit, as any change in the purpose of stay **will not be** approved in the RSA .

WARNING

Any applicant allowed entry into South Africa due to any **misrepresentation**, or **false declaration** on the application form or who sojourns in the Republic in contravention of his/her visa conditions shall be guilty of an offence and liable on conviction to a fine or to imprisonment as an illegal foreigner.

Any applicant who **overstays** as contemplated in section 50(1) of the Immigration Act shall be informed of his or her undesirability.
