In 2004, the AT Kearney Foreign Direct Confidence Index ranked South Africa in position 13 among 25 leading economies moving up two places from 2013.

Today, we are humbled to be ranked higher than countries such as Switzerland, Sweden and Netherlands.

The informed decision by Spain to choose South Africa as one of its priority markets outside the European Union has led to a new stage in Spanish-South African trade relations.

I am pleased to note that the presence of Spanish companies in South Africa is increasing exponentially.

They continue to contribute towards industrial output, employment, professional training and technological development in South Africa in keeping with our government's key priority areas.

In his State of the Nation Address on 12 February 2015, President Jacob Zuma identified several key focus sectors that require expansion and growth.

These have potential for creating large scale employment, and include:

- Energy supply;
- Transport and building infrastructure;
- Water and sanitation;

- The agricultural and agro-processing value chain;
- ICT infrastructure and broadband roll out;
- The mining value chain; and;
- The industrial manufacturing sector.

Clearly, South Africa remains amongst nations that strive to enhance inclusive economic growth that will lead to an increase in the creation of decent, sustainable jobs, advance the fight against poverty and accelerate the economic transformation with our countries.
