Application for Visa – Volunteer work

Please print the form DHA -84 and **to be completed only when you are at the Embassy** - with **BLACK INK** and submitted personally to the Embassy with the following:

- 1. One (1) recent passport photograph in colour;
- 2. A letter of invitation (from the company/institution in South Africa)
- 3. Confirmation letter from institution which the applicant represents confirmation of employment and aware of applicant is going to conduct volunteer work in South Africa
- 4. The company profile, tax and the company registration (Cipro) in South Africa;
- 5. Purpose or necessity of the work;
- 6. Nature of the work;
- 7. Proof of Qualification;
- 8. Duration of the work;
- 9. Place of the work;
- 10. Duration of the visit and proof of remuneration or stipend that the foreigner will receive from the employer;
- 11. Identity and contact details of the prospective employer or relevant contact person from the host institution; (copy of certified ID Document of the contact person in SA)
- 12. Proof of funds The last three months of your bank statement. If financed or sponsored by a company/institution, a confirmation letter should be submitted.
- 13. Proof of accommodation in SA
- 14. Travel insurance is compulsory.
- 15. Flight details.
- 16. Birth certificate (unabridged) where relevant to prove parenthood.
- 17. Marriage certificate where applicable.
- 18. The passport should be valid for not less than 30 days after the expiry of the intended visit. At least two unused pages should be available.
- 19. Receipt of proof of payment of NOK 455 to be transferred to the Embassy's AC 1503 15 38189 (IBAN NO: NO98 15031538189 DNB BANK).
- 20. Applicants must please indicate whether the passport will be collected from the Embassy. If the passport is to be returned by mail (registered mail) the applicant is requested to forward a self-addressed- **stamped**

<u>registered envelope</u>. Please forward a separate envelope for each passport. The postage fee per passport is between NOK 185.00 to NOK 200.00 for A5 size envelope and NOK 235.00 for A4 size envelope.

NOTE : For stay exceeding period of ninety days – Medical report, Radiological report and Police Clearance must be submitted
