Application for Visitor Visa to SA HOLIDAY PURPOSES

Please print the form DHA -84 and to **be completed only when you are at the Embassy** with **BLACK INK** and submitted personally to the Embassy with the following:

1. One (1) recent passport photograph in colour.

If the purpose of the application is for a visit to friends/family;

Friends/family visit, the applicant must submit all possible contact details (e.g. contact details of person(s), telephone numbers/addresses or whereabouts in South Africa) eg: Invitation letter from friend/relative in SA (LETTER MUST BE CERTIFIED BY SA POLICE), Copy of sponsor's SA ID, or valid SA permanent resident, Copy of SA Sponsor latest paid utility bill, and last 3 months bank statement, if the sponsor is responsible for accommodation and expenses of applicant during visit to SA,

Proof of funds – The last three months of your bank statement. If financed or sponsored by a company/institution, a confirmation letter should be submitted.

- 2. Proof of accommodation in SA for the whole duration in SA e.g. Hotel bookings
- 3. Travel insurance is compulsory.
- 4. Flight details.
- 5. Birth certificate (unabridged) where relevant to prove parenthood.
- 6. Marriage certificate where applicable.
- 7. The passport should be valid for not less than 30 days after the expiry of the intended visit. At least two unused pages should be available.
- Receipt of proof of payment of NOK 455 to be transferred to the Embassy's AC 1503 15 38189 (IBAN NO: NO98 15031538189 DNB BANK).
- 9. Applicants must please indicate whether the passport will be collected from the Embassy. If the passport is to be returned by mail (registered mail) the applicant is requested to forward a self addressed <u>stamped</u> <u>registered envelope</u>. Please forward a separate envelope for each passport. The postage fee per passport is between NOK 185.00 to NOK 200.00 for A5 size envelope and NOK 235.00 for A4 size envelope.
