Message from the Chargé d'Affaires

Dear Readers

I hope you enjoyed our last quarter Edition of the Newsletter.

As is the norm, President Cyril Ramaphosa delivered virtually the State of the Nation Address (SONA) on 11 February 2021 before a joint sitting of the two houses of Parliament under the theme: **"Following up on our commitments: Making your future work better"**. The intention of the SONA is to report back on progress achieved, challenges and crafting the future path. This year President Ramaphosa outlined the following priorities that government should be concentrating on:

- First, we must defeat the coronavirus pandemic,
- Second, we must accelerate our economic recovery,
- Third, we must implement economic reforms to create sustainable jobs and drive inclusive growth, and
- And finally, we must fight corruption and strengthen the state.

Indeed South Africa has been adversely affected by the coronavirus and impacted negatively on the economy, businesses, health, education and generally the wellbeing of our people. Many people lost their lives. Last year, the government declared a National State of Disaster in response to the COVID-19 pandemic and had to introduce measures to contain its spread. As of 6 April 2021, 1 552 853 cases were registered, 53 032 deaths and 1 478 820 recoveries. 272 438 health care workers vaccinated. The government has embarked on a vaccination program with the view to vaccinate the elderly with comorbidities. Addressing Parliament on 25 February 2021, the Minister

of Health, Dr Zweli Mkhize, assured that the country aimed at vaccinating 1.1 Million people by the end of March 2021. The second phase of South Africa's vaccine rollout programme is envisaged to start on 17 May 2021.

There are hurdles in realising this plan. The rich and developed nations have ordered for their citizens in advance. Although, the EU vaccination campaign lags behind other countries due to problems with the drugmaker, Astra, in fulfilling its delivery obligations to the 27-Nation Bloc, as COVID-19 cases rise on that continent.

Access to vaccines for developing countries has become frightening. To this end, our Government has secured 11 million doses of the Johnson & Johnson vaccine, which is said to be effective against the dominant variants in our country. The Aspen manufacturing plant in the Eastern Cape is involved in producing the Johnson & Johnson vaccines. The Government is also at various stages of negotiations with the manufacturers of other vaccines such as Pfizer, Sinovac, Sinopharm and Sputnik V.

Whilst dealing with the pandemic, President Ramaphosa chaired the 30th African Peer Review Forum of Heads of State and Government on 25 March 2021. Member states that participated at this virtual meeting included South Africa, Senegal, Mali, Burkina Faso, Benin, Niger, Mauritius, Nigeria, Djibouti and Egypt.

President Ramaphosa also undertook a visit to Tanzania to attend the funeral of late President John Pombe Magufuli who succumbed to heart conditions on 17 March 2021. President Ramaphosa in his tribute to the late President Magufuli recognised Tanzania's assistance during the struggle against apartheid colonialism in South Africa until the attainment of freedom in 1994; President Magufuli's strong believe in Pan-Africanism; economic development and the betterment of the lives of Tanzanians; President Magufuli's Swahili Language Diplomacy and again to thank Tanzania and its people for assistance rendered to South African liberation movements.

During the preparation of this Edition, we celebrated important dates of international and national significance which included amongst others, Valentine's Day, 14 February, International Women's Day, 8 March and the Human Rights Day, 21 March. The Month of March is regarded as the Human Right Month in South Africa and 21 March the Human Rights Day. The latter is important in the political calendar of South Africa as it is always celebrated in remembrance of Sixty-nine (69) people who were murdered by the apartheid police on 21 March 1960. This commemoration also provides the country with an opportunity to reflect on progress made in the promotion and protection of human rights. This year's Human Right Month was commemorated under the theme: "The year of Charlotte Maxeke: promoting human rights in the Age of COVID-19" and coincides with the 25th anniversary of the adoption of the Constitution.

The High Commission also wishes to announce that our Freedom Day on the 27 of April 2021 will also not take place due to prevailing health conditions.

News from South Africa

President Ramaphosa chaired African Peer Review Mechanism Meeting of Heads of State.

President Cyril Ramaphosa, in his capacity as Chairperson of the African Peer Review Mechanism (APRM), chaired the 30th African Peer Review (APR) Forum of Heads of State and Government meeting on Thursday, 25 March 2021.

President Ramaphosa assumed the Chair of the APRM in February 2020.

The APR Forum is a Committee of Participating Heads of State and Government of the member states of the African Union (AU) who have voluntarily chosen to accede to the APRM. This authority is the highest decision-making body in the APRM.

The APR Forum has ultimate responsibility for oversight of the APRM organisation and processes, for mutual learning and capacitybuilding and for exercising constructive peer dialogue and persuasion. These programmes are in place to make the APRM effective, credible and acceptable.

The 30^{th} Summit of the forum, among others, welcomed the Democratic Republic of Congo (DRC) as the newest member State to accede to the APRM.



"The Summit was expected to conduct the peer review of Liberia; discuss reports on targeted reviews of Sierra Leone and Zambia; receive a briefing on Sudan's governance gap analysis; and receive an update on progress in Nigeria's second review process.

"Kenya and Mozambique will also make presentations on implementation of their national programmes of action. President Ramaphosa will also use the opportunity of the 30th Summit of the APR Forum to apprise his counterparts about the progress of the 2nd Generation Review in South Africa," The Presidency said in a statement.

The APRM was established in 2003 as a specialised agency of the AU that serves as a platform for sharing experiences and reinforcing best practices towards political stability, accelerated economic growth and regional and continental integration as well as sustainable development.

It further seeks to foster change in underlying deficiencies in governance

and socioeconomic development processes among member states.

The mechanism uses a holistic review process that distinguishes it from other institutions through inclusive dialogue, independent and objective reviews, peer learning and compliance monitoring. – **Source: SAnews.gov.za**

AfCFTA: Alive with Possibilities

The South African Government says it will maximise the opportunities presented by the African Continental Free Trade Area (AfCFTA), which came into operation on 1 January 2021, following the adoption of the Johannesburg Declaration by the African Union.

The AfCFTA is set to create a massive market and demand for locally-produced machinery, clothes and food; provide a platform for South African businesses to expand into markets across the continent; and for South Africa to position itself as a gateway to the continent.

Delivering the 2021 State of the Nation Address on Thursday, 11 February 2021, President Cyril Ramaphosa said South Africa was already at work to reindustrialise the economy.

This, the President said, was being done through initiatives such as the Ford Motor Company's investment in the economy. The company recently announced a R16-billion investment in the South African market, which is expected to majorly bump up jobs and local production. Ford Motor Company announced a R16-billion investment to expand their manufacturing facility in Tshwane for the next generation Ford Ranger bakkie.

"This investment will support the growth of around 12 small and medium enterprises in automotive component manufacturing," the President said.

Nearly half of the procurement spend on construction of the bulk earthworks and top structure at the Tshwane Special Economic

Zone during this phase is expected to be allocated to small, medium and micro enterprises; an amount equal to R1.7 billion in procurement opportunities.

Furthermore, the President reiterated Toyota's investment in its KwaZulu-Natal facility to start production of the first generation of hybrid electric vehicles to come off a South African assembly line.

"This follows investment announcements by Nissan, Mercedes Benz and Isuzu in expanded production facilities, all of which cement South Africa's position as a global player in auto manufacturing.

"This year, our focus will be on getting the industry back to full production, implementing the Black Industrialists Fund and working on a new platform for expanded auto trade with the rest of the continent.

"This will be part of our concerted effort to boost the manufacturing sector," the President said. **Source: <u>SAnews.gov.za</u>**

President Ramaphosa addressed the Mining Indaba

President Cyril Ramaphosa delivered the opening remarks at the annual Investing in African Mining Indaba on Tuesday, 2 February 2021.

The indaba, which was held virtually this year, broadcast a pre-recorded address by the President.

The indaba was hosted under the theme: "Resilience & Regrowth: Adopting the New Mindset for African Mining".

It featured guest speakers, including the President of the Democratic Republic of Congo, Félix Tshisekedi; the President of the Republic of Sierra Leone, Julius Maado Bio; and the President of the Republic of Botswana, Mokgweetsi Masisi.

The President's address set out South Africa's progress in responding to the COVID-19 pandemic and highlighted opportunities for international investment and the critical role of the mining industry in rebooting the economy.



South Africa determined to Ramp up Vaccine Manufacturing Capacity

Deputy President David Mabuza has reiterated government's stance to ramp up efforts for the country to produce its own lifesaving vaccines, as the world battles COVID-19.

Deputy President Mabuza conducted an oversight visit at the Biovac Institute in Midrand, Gauteng, on Tuesday, 2 March 2021.

Biovac is a bio-pharmaceutical company, in partnership with government and the private sector. Established in 2003, with its headquarters in Cape Town, the company was set up to establish local vaccine manufacturing capability for the provision of vaccines for national health management and security.

"We do currently manufacture vaccines. Almost 80% of the vaccines we use are manufactured in Cape Town, and then we distribute. But we want to increase this capacity," said Deputy President Mabuza.

The company is the storage centre for the Johnson & Johnson vaccine, which is currently reserved for healthcare workers across the country following a decision by the Inter-Ministerial Committee (IMC) on COVID-19 Vaccines.

The Deputy President, who chairs the IMC, said after his visit to Biovac, that government was determined to improve the country's vaccine manufacturing capabilities.

The second batch of the single-dose Johnson & Johnson vaccine landed at OR Tambo International Airport from Belgium on Saturday, 27 February 2021.

The Deputy President believes that the country will not need another storage facility.

Everything that will come in will be stored here, and will go straight to vaccination sites from here," he said, speaking from outside the institute's cold room.

Deputy President Mabuza said he had every confidence in Biovac to safely store the vaccine. He assured that he would get vaccinated when his turn comes.

The Deputy President will be visiting various sites once government effectively rolls out the inoculation programme in the country. **Source:** <u>SAnews.gov.za</u>

The First COVID-19 Vaccine Developed in Africa

A group of South African Scientists has designed and developed the first COVID-19 vaccine of African origin, called Shantivax

Port Elizabeth-based immunotherapy company, Genlab, together with Danish biotechnology company, Immunitrack, have created a "next generation vaccine" that will elicit both an antibody and T-cell response.

"It will completely change the way the world perceives Africa in terms of innovation. We have a vaccine by Africa, for Africa and the developing world," said CEO of Genlab, Kamsellin Chetty.

"Next generation vaccines" are vaccines that have adapted and evolved from current vaccines to be safer and more effective.

"It's the first time that the concept and design for a COVID-19 vaccine has come from South Africa," said Chetty.

The Shantivax prototype is currently undergoing pre-clinical testing.

The vaccine uses a live, but weakened strain of bacterium that is known to be safe and will continuously stimulate the immune system to provide long-term protection against COVID-19.

"It has been designed to elicit a highly specialised respiratory immune response referred to as type I and type III interferon responses. The bacterium platform will transport a vector that will produce a small protein (peptides) called epitopes that are used to target COVID-19."

Shantivax can be administered through the skin into the bloodstream where it should elicit an antibody response and will use nanotechnology to travel from the bloodstream to the site of infection within the lung.

The vaccine can reside in the lung for a number of years while it continuously provides stimuli for the immune system to identify and neutralise COVID-19 before it replicates intensively.

Once the Shantivax vaccine has passed clinical trials, Chetty says they are hoping to outsource production to the Serum Institute of India. "The company has the capacity to produce a bacterial vaccine of this nature," he said.

According to Immunitrack CEO, Stephan Thorgrimsen: "This project presents a powerful approach to address the challenge in generating a lasting immune response against the emerging COVID-19 variants. Our in vitro HLA specific epitope mapping platform, NeoScreen, will enable Shantivax to address the urgent need for an effective, affordable and producible vaccine for the African continent". **Source:** www.iol.co.za

South Africa Looks to Asian Markets to Revive Economic Growth.

International Relations and Cooperation Minister, Dr Naledi Pandor, says government has created a significant footprint in Asian markets as part of efforts to return the country to pre-COVID-19 economic growth

The Minister said this when she participated in the debate on the State of the Nation Address on Wednesday, 17 February 2021.

"We will identify new opportunities and expand those that have benefit for South Africa. In pursuit of this objective, South Africa has created a significant footprint in Asia, which is the continent showing the most promise of a speedy return to pre-COVID-19 levels of economic growth.

"Last year, South Africa acceded to the Treaty of Amity and Cooperation to take up significant trade and development opportunities available in this region. We will Regional also benefit from the Comprehensive Economic Partnership of these countries. This partnership created the world's biggest trading bloc, estimated to account for about US\$26 trillion or 30% of global gross domestic product, and 28% of global trade," Minister Pandor said.

The Minister said in response to the President's call of intensifying efforts to stimulate growth, government was working tirelessly to raise South Africa's global visibility by also "promoting [South Africa] as the best place to be, to do business, to visit, to work, to study and to live".

"We are also responding to new opportunities and harnessing the collective capabilities of DIRCO's resources both at home and abroad," Minister Pandor said.

South Africa, the Minister said, would leverage engagement with the Association of Southeast Asian Nations to enhance mutually beneficial trade, investment and tourism ties, and to support skills development and training for South Africans.

Minister Pandor said South Africa secured significant beef export opportunities to the Malaysian market as of November 2020.

"Market access was also obtained for fruits to Thailand. Product protocols are being negotiated in the region and are at an advanced stage. These include table grapes to Vietnam and South Korea, avocadoes to India and Japan, and pears to China and India.

"Total two-way trade with Asia and the Middle East (inclusive of Oceania) breached the

important milestone of R1 trillion, for the first time, in 2019 and is set to grow further."

Many companies from the Asian region have made significant investment pledges during the President's Investment Summits and State Visits.

Companies such as Toyota, Isuzu, Tata Motors, Mahindra and Motherson Sumi have expanded their investments in the country.

China has pledged to invest US\$14 billion, and Saudi Arabia and the United Arab Emirates US\$10 billion each.

"We aim to build on these successes by ensuring growing global trade, which is one of the best ways to fight poverty, inequality and unemployment in our country and our continent," said Minister Pandor. **Source:** <u>SAnews.gov.za</u>

Minister Pandor led the South African delegation to a Virtual Meeting of SADC Council of Ministers

The Minister of International Relations and Cooperation, Dr Naledi Pandor, participated in the virtual Southern African Development Community (SADC) Council of Ministers on 12 and 13 March 2021.

Like all regional and intergovernmental bodies, SADC was also affected by the outbreak of COVID-19, which forced it to conduct its meetings in this manner.

As customary, the statutory Council of Ministers deliberated on issues that contribute towards the consolidation of regional cooperation and integration. The SADC region has several programmes and policies for its integration agenda that are being implemented and operationalised by the SADC Secretariat based in Gaborone, Botswana.

The Council of Ministers reflected on SADC's ongoing programmes of work, monitored implementation of activities and recommend future projects for the organisation for approval by the SADC Summit of Heads of State and Government.

Among key issues tabled before the Council was an update on the COVID-19 pandemic situation in the region; the implementation plan of the recently Regional Indicative approved Strategic Development Plan 2020 - 2030; a progress report the implementation of the SADC on Industrialisation Strategy and Roadmap: transformation of the SADC Parliamentary Forum into a regional Parliament; the recruitment process of the Executive Secretary and Deputy Executive Secretary for Regional Integration; and reports of the Human Resources and Administration Committee.

The Council of Ministers was preceded by the meetings of the Standing Committee of Senior Officials and Finance Committee

Minister Pandor Delivered Opening Address for the African Union Development Agency (AUDA) NEPAD 6th Annual Programme for Infrastructure Development (PIDA) IN Africa.

The Minister of International Relations and Cooperation, Dr Naledi Pandor, on Tuesday, 19 January 2021, virtually delivered the opening address of the Sixth Annual PIDA Week.

The PIDA Week is held annually in different AU member states to assess and accelerate the implementation of the infrastructure programmes.

PIDA is the AU's strategic framework for regional and continental infrastructure development, guiding the continental infrastructure development agenda, policies and investment priorities.

It provides a framework for engagement with Africa's development partners on the provision of regional and continental infrastructure and facilitates the physical, economic and social integration of the continent in support of the African Continental Free Trade Area.

PIDA brings together continental infrastructure initiatives and regional master plans into one coherent infrastructure investment programme with an implementation strategy and portfolio of projects for prioritised implementation, the PIDA Priority Action Plan (PIDA-PAP). PIDA-PAP covers the four key infrastructure sectors of transport, energy, ICT and transboundary water resources, and the first phase comprises more than 400 projects in 51 cross-border programmes for implementation until the end of 2020

Cabinet Approves UN ICERD Periodic Report

Cabinet has approved the submission of South Africa's ninth to 11th periodic country report on the United Nations (UN) International Convention on the Elimination of All Forms of Racial Discrimination (ICERD).

This was in accordance with South Africa's commitment to the ICERD in 1994, which was ratified on 10 December 1998.

This was confirmed by acting Minister in The Presidency, Khumbudzo Ntshavheni, while addressing the media on the outcomes of the recent Cabinet meeting.

"The report outlines progress made by South Africa in putting in place legislative, judicial and administrative measures to eliminate all forms of racial discrimination," said the Minister.

She said the periodic report focussed on the progress made in advancing equality, fighting xenophobia and other related intolerance, prevention of hate crimes, and highlights challenges that still remain. After its presentation to the relevant body, the report will be made public.

In the meeting, Cabinet also approved the tabling of the International Convention on the Suppression and Punishment of the Crime of Apartheid to Parliament for accession.

"This is done in terms of Section 231(2) of the Constitution of the Republic of South Africa of 1996. The convention, among others, declares apartheid as a crime against humanity and that it posed a serious threat to international peace and security," she said.

Once approved by both houses of Parliament, the Department of International Relations and Cooperation will deposit the instrument of accession with the UN, said the Minister.

Also agreed to in the Cabinet meeting was the amendment of the agreement between South Africa and the Netherlands on social security.

The cooperation agreement on social security was signed in The Hague in May 2001.

The agreement facilitates the export of social security benefits for the respective citizens.

"The Netherland Social Security Policy has made amendments to its export social

security in respect to the Dutch children. The proposed amendment is to align the agreement to these changes," said the Minister.

South Africa Welcomes the Entryinto-force of the Treaty on the Prohibition of Nuclear Weapons

On 22 January 2021, the United Nations (UN) Treaty on the Prohibition of Nuclear Weapons (TPNW) entered into force

Marking the event, International Relations and Cooperation Minister, Dr Naledi Pandor, stated: "Today marks a turning point in humanity's endeavour to rid the world of nuclear weapons. It is the culmination of that very first UN Generally Assembly Resolution in 1946, which sought to deal with the elimination of nuclear and other weapons weapons adaptable to mass destruction. It cannot be overemphasised that the TPNW is not the final word on nuclear weapons, but a critical step in the evolution of the regime that would be required to achieve and eventually maintain a world without nuclear weapons. Its approach is consistent with the approach taken in the elimination of other unacceptable weapons, where prohibition preceded elimination".

South Africa is of the view that the TPNW represents one of the most important developments in the area of nuclear disarmament since 1945. The TPNW not only complements the Nuclear Non-Proliferation Treaty (NPT) but strengthens the NPT as the TPNW represents the highest nonproliferation standard that any state can commit to. It also provides the opportunity for those states that are not located in nuclear-weapon-free zones to join an instrument that expresses their total opposition to nuclear weapons.

The denuclearisation of South Africa is symbiotically linked to our democratisation. In his last address to the UN General Assembly in 1998, President Nelson Mandela posed a pertinent question in relation to nuclear weapons as he said: "We must ask the question, which might sound naive to those who have elaborated sophisticated arguments to justify their refusal to eliminate these terrible and terrifying weapons of mass destruction – why do they need them anyway!"

Minister Pandor concluded: "Let me take this opportunity to renew South Africa's commitment to the total elimination of nuclear weapons as the only guarantee that nuclear weapons will never be used again by anyone under any circumstances".

South Africa to Host International Philately Exhibition (IPEX)

Cabinet recently approved the hosting of the IPEX, also known as the stamps exhibition, in Cape Town from 9 to 19 December 2021 under the theme: "Road to Democracy".

The Federation of International de Philatelie (FIP) initially planned to stage the event in Cape Town from 17 to 20 March 2021 but it was moved to the later date due to COVID-19.

The Department of Communications and Digital Technologies will organise and host the event in collaboration with the FIP organising committee.

Stamps collected will display historic moments, individuals and events that contributed in enhancing democracy in South Africa. The anticipated visitors will contribute towards the country's tourism, boost local economy and promote culture and social

New from Dar Es Salaam

SANDF Delegation Visits Dar es Salaam

A delegation from the South African National Defence (SANDF) paid an official working visit to Tanzania from 28 February – 4 March 2021. The objective was to strengthen defence relations between the two countries with a view to conclude a legal framework.

Tanzania and South Africa contribute to the peace efforts in the Democratic Republic of Congo (DRC) and wish to continue working together to achieve peace and security in the DRC.

South African Business Forum held on 18 February 2021

The South African High Commission hosted the first South African Business Forum (SABF) meeting of 2021 at Hyatt Regency Hotel in Dar es Salaam.

Ms Stella Dhlomo-Imieka as the Chargé ď Affaires chaired the meeting.

The objective of the meeting was to interact with the South African Business Community and share experiences of business operations and environment. Due to healthy situation in Dar es Salaam, the meeting was not well attended. Nevertheless, members felt to continue with the meeting as the quorum was reached. Therefore, the objectives of the meeting were met.

An update on the registration of SABF as a legal entity was presented and was indicated that all legal processes have been completed; therefore the forum is just waiting for signatories. Only one signature is missing.



Furthermore, it was proposed that the SABF money has to be utilised for the development of and betterment of the people of Tanzania leaving behind a legacy of SABF and members. This means projects should be identified and the Committee should identify projects and present a plan for the year early in 2021.

The Chair raised TWO issues to be shared with the group. One was the State of the Nation Address (SONA) and COVID- 19 pandemic in South Africa With regards the former, the Chair gave an exposition on salient points contained in the speech, which are:

- The state of COVID-19 in South Africa and interventions by the government,
- An explanation on vaccine roll out and challenges confronted,
- Economic Recovery Plan,
- Corruption and resultant prosecution,
- Triple challenges of inequality, poverty, unemployment and how to address these challenges, and
- Government Programme of Action for 2021

President Ramaphosa Attends the funeral of Late President Magufuli

The then Vice President of the United Republic of Tanzania, H.E. Ms Samia Suluhu Hassan announced on 17 March 2021 the death of late President John Pombe Magufuli due to heart complications at Muzena Hospital in Dar es Salaam. He is the first Tanzania's Head of State to have died in Office aged 61.

The State Funeral took place on 22 March 2021 at Jamhuri Stadium in Dodoma. The body of late President was viewed by the public in Dar es Salaam; Dodoma; Zanzibar Mwanza; Geita and lastly Chato, in Geita Region, where the burial took place on 26 March 2021.

Thousands arrived in Dodoma to attend the funeral and it was a grieving mood at the stadium and the city as well. The State funeral was attended by approximately ten African Heads of States and Government the Southern African from Development Community (SADC) and the East African Community (EAC). This inter alia included Kenya President, Mr Uhuru Kenyatta, South African Mr President Cvril Ramaphosa, Botswana President, Mr Mokgweetsi Masisi, Malawi President, Mr Lazarus Chakwera, President of the Democratic Republic of Congo Mr Felix Tshisekedi, Comoros President, Mr AzaLli Assoumani, Zambia President Mr Edga Lungu, Zimbabwe President Mr Emmerson Mnangagwa, and Mozambique President Filipe Nyusi.

President Ramaphosa accompanied by the Minister of International Relations and Cooperation, Dr Naledi Pandor attended the State Funeral in Dodoma. President Ramaphosa in his tribute to the late President Magufuli recognised Tanzania's assistance during the struggle against apartheid colonialism in South Africa until the attainment of freedom in 1994; President Magufuli's strong belief in Pan-Africanism; economic development and the betterment of the lives of Tanzanians; President Magufuli's KiSwahili Language Diplomacy and again to thank Tanzania and its people for assistance rendered to South African liberation movements.
