APPLICATION FOR AN ADULT PASSPORT

All Police stations in NZ will no longer provide fingerprint services for the application of South African passports and ID books.

Applicants MUST TRAVEL TO WELLINGTON AND WE WILL ASSIST YOU

Be advised that an appointment is necessary. Appointments are: Monday, Tuesday, Wednesday and Friday between 9am and 1pm.

Please contact this office to make an appointment on 04 8158484 during the hours of 9am - 5pm, Monday to -Friday or email consular.wellington@dirco.gov.za .

Please note, applications are forwarded to the Department of Home Affairs in South Africa for processing. Therefore, *applications take approximately 6 to 12 months to be finalised.*

Applicants are requested not to contact the High Commission unnecessarily for progress on passport and other applications. These requests ultimately delay the process. This office will get in touch with applicants when their documents are ready.

Do not make firm travel bookings before obtaining your passport.

All forms need to be completed in **black ink**

Please ensure that you completely answer the forms—leaving no blanks. If something is irrelevant please indicate so with an “n/a” (not applicable).

SA passport application requirements:

1. **Form BI-73** **Passport application form** **Pre fill form**
Note this office will complete Sec B of this form upon your appointment.
First Adult Passport: Both parents to sign section C. Applicant to sign section E.
2. **Form BI-529 - Determination of Citizenship Status** **Pre fill form**
This form is required for all passport applications applied for outside of South Africa.
Please mark N/A to questions that are not applicable - do not leave anything blank.
Please note questions A9 & A10 MUST be answered and section 'E' signed by the applicant or the form will be returned
3. **DHA-9 form** **Full set of fingerprints**

This form is not downloadable. You will receive it to complete on day of your appointment.

4. **Form DI-47 Loss of passport report and police report**
To be submitted for lost/stolen passport—if applicable.
5. Bring the original and copy of your current passport OR identity document OR birth certificate.
This office can certify the copy as long as the original is shown.
6. A certified copy of your foreign citizenship certificate and your dual citizenship certificate - if applicable.

In cases of those applicants who acquired foreign citizenship through descent, a certified copy of your own full birth certificate showing the birth places of your parent(s) is required.

Under circumstances where even the parents acquired such citizenship through descent, a letter from the relevant authorities of the country concerned will suffice.

Documents issued in a foreign language must be officially translated to English by a sworn translator.

This office can certify the copy as a true copy of the original as long as the original is provided.

7. Applicable to women

If you want your passport to be issued in your maiden / married surname, a formal letter of request must also be included together with a certified copy of your divorce / marriage certificate.

8. Photographs

Four (4) clear, professionally taken colour photos of full face of applicant, showing only head and shoulders measuring 35mm x 45mm.

Include the photos but do not attach them to the form.

Officials at the High Commission official will certify photos on day of your appointment.

9. If you are a naturalised South African, a certified copy of your Naturalisation Certificate.

10. Fees for passports

Adult/children regular passport	NZ\$114.00;
Maxi passport	NZ\$229.00;
Lost/stolen/damaged passport	NZ\$229.00.

Only cash is accepted.

11. Return prepaid courier bag (self-addressed)

The courier bag must be track and trace. It is for domestic use only. It will be used to return to you the issued passport/document on receipt from DHA.

12. Signed declaration of return address

13. **Black Pen. You will be required to use this during your appointment.**

14. Please bring with you a **Face Mask. You will be required to wear a face mask during your time at the High Commission.**

If you or somebody in your party is differently-abled please reach out so that we can endeavour to make your time more accessible.
